MARY BREVOORT TOWLE

Funeral services were held Saturday in the chapel at the Miriam Osborn Memorial Home for Miss Brevoort Towle, 74, who died last Thursday at the Home after a long illness. Interment was in Woodlawn Cemetery, the Bronx.

A descendant of one of the oldest families in this area, Miss Towle was born June 10, 1895, and lived for many years in what she termed "the shanty" on the old Brevoort farm, in what is now the Greenhaven section of Rye.

In 1875, Henry Brevoort had divided his farm among his three daughters and their husbands and Miss Towle was the granddaughter of one of these three couples. Mr. and Mrs. Stevenson Towle.

She was a daughter of the late Henry and Louise (Odell) Towle, and later in life lived at Chestnut Gardens, Rye, until her retirement.

Miss Towle was educated at the Manor School, Larchmont, and began her work at Rye Country Day School as a secretary in 1925. While there, she studied at and was graduated from the Bank Street School in New York City which specialized in kindergarten teacher-training.

She taught at the Rye Country Day School from 1941 until her retirement in 1959, and in 1960 entered the Osborn Home with her sister, Miss Alice Brevoort Towle, two years her senior, who survives

Other survivors include another sister, Mrs. Charles Ward, Tulsa, Okla., and two nieces, Mary Louise Crommett, East Hampton, L. I., and Cornelia Robinson, Knoxville, Tenn.

Gleason, residents of the east side of the street told the council they favor the new regulation. Mr. Martin stated that there is only four feet of space between the pavement and the sidewalk in front of his house, consequently cars have parked on the walk and broken it. thereof and adding the following "I'm in favor of the restriction the road is much too narrow for parking on both sides," he said.

## **Business Section Changes**

It also designated 15-minute parking on the north side of Purdy Ave. and on the east side of the post office to Third St.

The new ordinance eliminates parking on both sides of Purdy Ave. between Purchase St. and First St., on the south side of Purdy Ave. between School St. and Boston Post Rd.; on the north side of Purdy Ave. between Boston Post Rd. and the east side of the post office property and on the north the official seal of the City of Rie side of Purdy Ave. from Third St. in a westerly direction for a distance of 50 feet.

ORDINANCE NO. 1—1970 Be it ordained by the Council of the City of Rye as follows:

Section 1. Section 6-1.3 of the General Ordinances of the City of Rye is hereby amended by redesignating said section subsection (b) subsection (a):

(a) One-way streets. Elizabeth Street is hereby designated for one-way traffic in a westerly direction.

Section 2. Paragraphs 1 and 2 of section 6-2.6(c) of the General Ordinances of the City of Rye are hereby amended to read as follows:

1. On the east side of Third Street from Purdy Avenue to the post office driveway, and on the west side of Third Street from Purdy Avenue in a westerly direction for a distance of luu ieet.

2. On the north side of Purdy Avenue from the east side of the post office property to Third Street.

Section 3. Section 6-2.7(a) of the General Ordinances of the City of Rye is hereby amended by amending paragraph 8 thereof and adding two additional paragraphs to said section, to read as follows:

8. On both sides of Purdy Avenue between Purchase Street and First Street, on the south side of Purdy Avenue between School Street and Boston Pest Road, on the north side of Purdy Avenue between Bost in Post Road and the east side of Purdy Avenue from Third Street in a westerly direction for a distance of 50 feet.

11. On the east side of Da is Avenue between Manursi g Avenue and Sylvan Place. 12. On the north side of Eliza-

beth Street. Section 4. This ordinance shill take effect upon the publication thereof.
